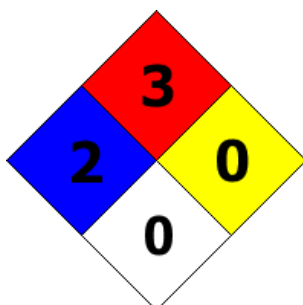

### After skin contact:
