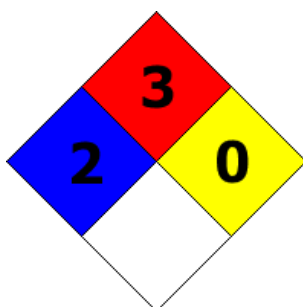

##### Description of first aid measures

###### After inhalation:
