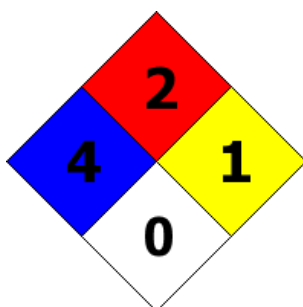

Cadmium Metal

After inhalation:

Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Consult a physician.

After skin contact:

Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Take victim to hospital. Consult a physician.

After eye contact:

Protect unexposed eye. Rinse/flush exposed eye(s) gently using water for 15-20 minutes. Remove contact lens(es) if able to do so during rinsing. Consult a physician.

After swallowing:

Rinse mouth thoroughly. Do not induce vomiting. Have exposed individual drink sips of water. Seek medical attention if irritation, discomfort or vomiting persists. Never give anything by mouth to an unconscious person.

SECTION 7: Handling and storage

Precautions for safe handling:

Minimize dust generation and accumulation. Follow good hygiene procedures when handling chemical materials. Refer to Section 8. Further processing of solid materials may result in the formation of combustible dusts. Provide ventilation for containers. Do not eat, drink, smoke, or use personal products when handling chemical substances. Avoid contact with eyes, skin, and clothing.

Conditions for safe storage, including any incompatibilities:

Store away from incompatible materials. Protect from freezing and physical damage. Keep away from food and beverages. Provide ventilation for containers. Appropriate Engineering controls:

Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling. Provide exhaust ventilation or other engineering controls to keep the airborne concentrations of vapor or dusts (total/respirable) below the applicable workplace exposure limits (Occupational Exposure Limits-OELs) indicated above. It is recommended that all dust control equipment such as local exhaust ventilation and material transport systems involved in handling of this product contain explosion relief vents or an explosion suppression system or an oxygen deficient environment.
