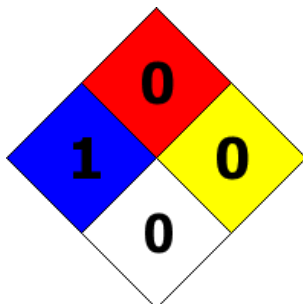

Description of first aid measures

After inhalation:

Methods and material for containment and cleaning up:

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Place into properly labeled containers for recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration.
