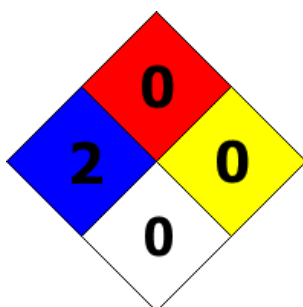

After inhalation:
