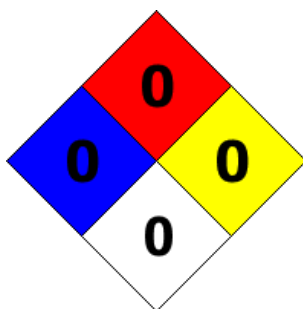

Description of first aid measures

After inhalation:
