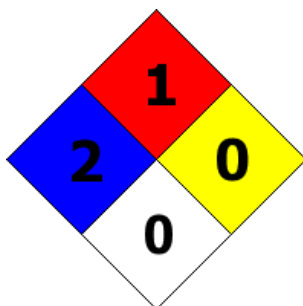

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures:

SECTION 7: Handling and storage

Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials.
