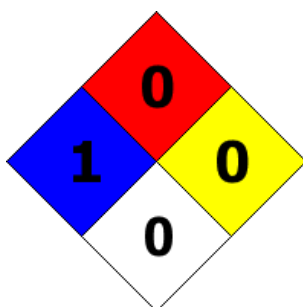

SECTION 7: Handling and storage

Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing.

Conditions for safe storage, including any incompatibilities:

Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Store with like hazards.
