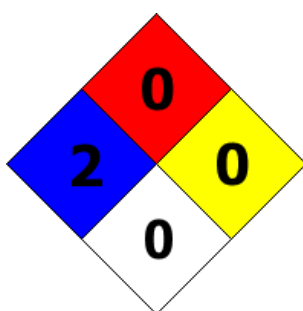

#### Description of first aid measures

##### After inhalation:

### SECTION 5: Firefighting measures

#### Extinguishing media

##### Suitable extinguishing agents:
