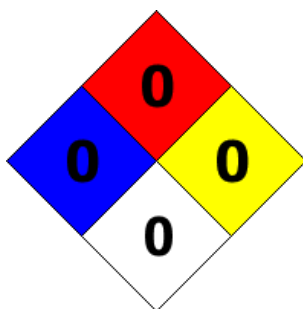

Description of first aid measures

After inhalation:

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures:

Wear protective equipment. Ensure that air-handling systems are operational. Ensure adequate ventilation.

Environmental precautions:

Prevent from reaching drains, sewer or waterway. Collect contaminated soil for characterization per Section 13. Should not be released into environment.

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Refer to Section 8. Always obey local regulations.
